LARGE FIGHT IN OCEAN CITY RESULTS IN THREE ARRESTS

On November 29, 2009, at approximately 1:13 a.m., Ocean City Police responded to Castaway's Bar & Restaurant located at 105 64th Street, in reference to a fight in progress.

Officers arrived at the scene and encountered a crowd of approximately 350 to 400 persons. There were several small fights occurring inside the establishment. Due to the size and uncooperative nature of the crowd, additional police personnel from the Worcester County Sheriff's Department and the Maryland State Police responded to assist OCPD with dispersing the crowd.

Ocean City Police made a total of three arrests:

- Shanice Lavea Fooks, 24-years-old, of Salisbury, Maryland
 - o Charged with Obstructing and Hindering a Police Officer.
- Deonna Taccura Bailey, 27-years-old, of Berlin, Maryland
 - o Charged with Resisting Arrest, Failure to Obey a Police Officer and Disorderly Conduct.
- Tyronn Rashaad Lawson, 22-year-old, of Berlin, Maryland
 - o Charged with 2nd Degree Assault, Resisting Arrest and Disorderly Conduct.

All three suspects were seen by an Ocean City District Court Commissioner and released on their own recognizance.

The OCPD is continuing to investigate this incident. Additional charges are pending.
